
RAFFLE APPLICATION:

WHEREAS, there exists a need for Alternate Conflict Public Defenders, and


WHEREAS, funds are available for this purpose, and

APPOINTMENT OF AN ALTERNATE MUNICIPAL PROSECUTOR



WHEREAS, there exists a need for a Judge, and


WHEREAS, funds are available for this purpose, and
