ORDINANCE 2012 - #5
AMENDING CHAPTER 81, OF THE TOWNSHIP CODE ENTITLED
"SHADE TREE COMMITTEE"

BE IT HEREBY ORDAINED by the Township Committee of the Township of Riverside, County of Burlington, State of New Jersey, that the Township Code be and is hereby amended as follows:

SECTION I. AMENDED SECTION

Chapter 81 shall hereafter read as follows:

§ 81-1. Committee established; membership and terms; responsibilities.

A. A Committee on Shade Trees is hereby established in the Township of Riverside. The Committee shall consist of the five members of the Township Committee and the Township Administrator

B. The Shade Tree Committee shall have the following responsibilities:

(1) Review any and all matters relating to shade trees, ornamental trees and shrubbery within the Township of Riverside now located or which may hereafter be planted in/on any public highway, park, parkway, or easement, except for those under the jurisdiction of the New Jersey Highway Department or the County of Burlington, including reviewing requests to plant or remove such trees, and make recommendations to the Township Committee or the Director of Public Works. Such requests must be in writing and will be brought to the Committee by citizens of the Township, by the Department of Public Works or by any Township employee.

(2) Review and make recommendations regarding the care and use of ground surrounding shade trees and related vegetation as previously described, to assist in their proper growth, care and protection.

(3) Recommend that any tree or part thereof which is dangerous to public safety be moved or removed.

(4) Make recommendations for the care and control of Township parks and parkways.

(5) Take direct action to encourage arboriculture within the Township and make recommendations to the Department of Public Works and/or the citizens for that purpose.

(6) Review and recommend the administration of treatment to or removal of any trees situated on private property which are believed to harbor a disease or insects which may be communicable to neighboring healthy trees in the care of the Township. In the event that such recommendations are made, the owner of any such property, for the purpose of providing treatment or removing such trees, will be notified in writing by the Township Administrator.

§ 81-2. Unlawful acts.

It shall be unlawful for any person to commit any of the following acts to shade or ornamental trees and shrubberies on streets, highways, parkways, easements and parks or

other lands owned by the Township without permission: to plant, set out, remove, take down, break or injure any such trees, shrubs or parts thereof unless recommended by the Committee and approved by the Township Administrator at the direction of the Township Committee, which approval shall be set forth in writing.

§ 81-3. Removal of trees; Charges to property owners; liens; exceptions.

Effective July 1, 2012, property owners shall be responsible for the removal of any such trees, shrubs or parts thereof classified as "shade trees" upon direction of the Township. Said responsibility shall be for the removal and disposal of the "shade trees." Upon the recommendation of the Committee, the Township Administrator may determine to charge real estate in front of which trees are planted, treated or removed, as an improvement thereof if the property owner does not remove said "shade trees" within thirty (30) days of notification, or a mutually agreed upon and memorialized time period. If it is determined that such cost is to be paid by the owner, it shall be certified by the Collector of Taxes in the municipality and billed to said owner. Should the owner fail to remit payment to the Township of Riverside within thirty (30) days of the date of the invoice, the amount shall thereupon become and be a lien upon said real estate and shall be included in the next tax bill rendered to the owner or owners thereof and be collected in the same manner as other taxes against that property. No such lien shall be applied to any planting to replace any tree or trees theretofore planted by the Township, nor to any planting in connection with Arbor Day exercises or other educational demonstration. In any case where it is determined to apply such cost to the adjacent property, notice of such intent shall be given to any owner or owners to be charged prior to incurring any expense, unless the same shall be deemed an emergency.

§ 81-4. Violations and penalties. Editor's Note: Amended at time of adoption of code; see Ch. 1, General Provisions, Art. I.

Refer to Chapter 2, Violations.

§ 81-5. Disclaimer of liability.

Nothing in this chapter shall be construed to make the Committee, the Township or any employee thereof responsible for the death or injury of any person or for damage to any property or highway caused by or related to any tree or shrub covered by the terms of this chapter.

§ 81-6. Effect on previous provisions.

All ordinances duly enacted by the prior Shade Tree Committee shall remain in full force and effect, unless otherwise indicated.

SECTION II. REPEALER, SEVERABILITY AND EFFECTIVE DATE

- A. Repealer. All Ordinances and provisions thereof inconsistent with the provisions of the Ordinance shall be and are hereby repealed to the extent of such inconsistencies.

- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective. The Ordinance shall take effect upon proper passage in accordance with the law.

SECTION I. AMENDED SECTION

The Township shall make the following changes:

§ 243-25. Schedule X: Loading Zones.

In accordance with the provisions of § 243-9, the following described locations are hereby designated as loading zones:

Madison Street NE Between Lafayette Street and Monroe Street

RIVERSIDE TOWNSHIP COMMITTEE

ORDINANCE 2012 - #7
AMENDING CHAPTER 225, OF THE TOWNSHIP CODE ENTITLED
"SOLID WASTE"

BE IT HEREBY ORDAINED by the Township Committee of the Township of Riverside, County of Burlington, State of New Jersey, that the Township Code be and is hereby amended as follows:

SECTION I. AMENDED SECTION

The Township shall make the following changes:

Amend § 225-13. Establishment of Curbside Program.

D. All residents of the Municipality within the area serviced by the curbside program established pursuant to this section shall source separate all designated recyclables and shall place them at the side of the road fronting their residence in the manner designated by this Ordinance and on the date specified for collection by the schedule published by the Municipality or County.

Amend § 225-14. Requirements Applicable to Source Separation and Collection of Designated Recyclables for the Curbside Program.

A. All recyclables placed at the roadside by residents for collection pursuant to the curbside program established pursuant to this Chapter shall be prepared for collection in accordance with the following:

B. Cardboard and paper shall be set out in carts provided by this municipality.

- a. Boxes shall be flattened as to fit into the cart.
- b. Where cardboard boxes are too large to be placed in the cart and where there are too many boxes to fit within the cart, cardboard boxes must be flattened and placed alongside the cart for collection.
- c. Carts shall be placed at the curb with the lid opening facing the street.
- d. Carts shall be placed in such a manner so as to leave at least two (2) feet of clear space around each side of the cart.
- e. Carts shall be placed in such a manner so as to avoid interference from overhead obstructions.
- f. Carts shall be maintained in a neat and sanitary condition so as to deter vermin and odors.
- g. Carts are the property of the municipality and may not be used for any other purpose or to contain any other material.

225-19. Unlawful Activities; Nuisance.

A. It shall be unlawful for:

5. any person to utilize the municipality provided recycling carts/containers for any purpose other than recycling whatsoever.

6. any person to remove recycling carts/containers provided by the municipality, as they are municipal property that has been assigned to each specific block and lot and not its

owner.

B. All unlawful conduct, including the misuse of recycling containers/carts for trash, theft of containers, as set forth in Section 10 (a) shall constitute a public nuisance and shall be subject to action in accordance with Chapter 2, Violations, of the Codes of the Township of Riverside.


PUBLIC PORTION
