- 1. The Tax Collector is directed to prepare and issue estimated tax bills for the Municipality of Riverside Township for the third quarter 2015, in accordance with the provisions of N.J.S.A. 54:66.2et seq.
- 2. The entire estimated tax levy for 2015 is hereby set at \$14,948,290.10
- 3. The Tax Collector takes any additional steps necessary to immediately implement this resolution.
