DEPARTMENT OF PUBLIC WORKS:

Mr. Frey reported that Christmas tree pick up will continue until January 26, 2018. Pot holes are continuing to be filled. 2,720 cubic yards of leaves have been picked up. There was a very serious truck fire concerning one of the Public Works trucks. The Public Works yard is open every fourth Saturday from 10:00am – 2:00pm. Mr. Miller questioned if the remaining trucks have been inspected. Administrator Jack stated that all the trucks are inspected and explained that a member of the Fire Department was with the Public Works Employee when the incident occurred and stated that the truck smelled like an electrical fire, then employee returned the truck to the Public Works Yard. Mr. Frey thanked Burlington County for donating a truck to the Township to use.
