The regular meeting of the Riverside Township Committee was held on the above date at the Riverside Township Municipal Building 1 W. Scott Street Riverside, NJ 08075.

APPROVAL OF MINUTES:

Motion made by Mr. Kirk and Mr. Kimble that the following minutes be approved: The Work Session Meeting of January 27, 2020, the Regular Meeting of January 27, 2020, the Closed Session Minutes of January 27, 2020 and the Work Session Meeting of February 3, 2020. Upon roll call the vote was as follows: Ayes – Messrs. Kirk, Kimble and Frey and Mrs. Hatcher. Nays – None. Abstain – Mrs. Weaver. Motion carried.

OPEN PORTION AGENDA ITEMS:

Mayor Frey opened the meeting to the public for agenda items only.



- 1) Michelle Higgenbothem 222 Rancocas Avenue Ms. Higgenbothem stated that she is voicing her concern for people that are not in attendance. Ms. Higgenbothem stated that the major concern is that the money is being moved from a truck reserve to fund the fire station budget. Ms. Higgenbothem stated that although their Public Notice was posted in the designated places, only 17 people voted for the Fire District's Special Election. Ms. Higgenbothem questioned if the Fire District uses the truck money, how would they be able to purchase a new truck?
- 2) Kamilla DaSilva 200 S. Fairview Street Questioned when a new truck will have to be purchased? Fire Commissioner Conard Jr. stated that possibly 5 years. Ms. DaSilva questioned if the 3.5 million will be used for the new building? Commissioner Conard answered in the affirmative. Administrator Jack explained the budget procedure.
- 3) Mike Hart 800 Devon Road Mr. Hart questioned how much was approved for the new building? Commissioner George Conard Jr. stated that 3.5 million was approved. Mr. Hart questioned wouldn't it have been easier to ask for the 3.7 million? Commissioner Conard Jr. answered stating that the voters specified that they did not want to go above 3.5 million.
- 4) Ann Law 6 Grant Street stated that she is a bookkeeper. Ms. Law voiced concern that the Fire District is taking money from their reserve and questioned if there is excess money, will it be replaced? Fire Commissioner Conard answered that if he is allowed by the Department of Community Affairs to return any excess money, he will. Ms. Law questioned how can the residents be ensured that they will get the best bid? It was stated that they have to take the lowest bid. Ms. Law questioned if the Professionals were appointed. Fire Commissioner Conard answered in the affirmative.

In seeing that no members of the public wishing to speak, motion made by Mrs. Hatcher and Mr. Kimble to close Public Portion (Agenda Items Only) carried.

RESOLUTION 2020 - #44

RESOLUTION OF THE TOWNSHIP OF RIVERSIDE AUTHORIZING AMICUS PARTICIPATION AND FUNDING ASSISTANCE IN THE APPEAL OF VERIZON NEW JERSEY INC.

<u>V.</u> HOPEWELL BOROUGH

WHEREAS, on January 28, 2018, the New Jersey Tax Court ruled in favor of Hopewell Borough ("Hopewell") in the case of Verizon New Jersey Inc. v. Hopewell Borough ("Hopewell Litigation"), and affirmed the ten-year decision of the Mercer County Tax Board regarding Verizon's obligation to pay business personal property tax to Hopewell for the year of 2008; and

WHEREAS, an appeal and cross-appeal have been filed by Verizon and Hopewell; and

WHEREAS, Verizon is challenging the constitutionality of N.J.S.A. 54:4-1, which requires the payment of personal property taxes by Verizon and certain other telephone service providers; and

WHEREAS, the outcome of the appeal will affect Riverside Township's continued collection of personal property tax pursuant to N.J.S.A. 54:4-1; and

WHEREAS, Joel Shain, Esq., of the law firm of Shain Schaffer PC ("Shain Schaffer") serves as Public Utility Counsel for the League of Municipalities ("League"); and

WHEREAS, the League is participating the Appeal as *Amicus Curiae* ("Amicus") and has engaged Shain Schaffer to act on its behalf; and

WHEREAS, the League has requested that Riverside Township and other affected municipalities participate and share in the cost of the appeal by joining the League as *Amicus* and contributing \$2,000.00 toward its counsel's fees; and

WHEREAS, joining the League in this appeal is in the public interest; and

WHEREAS, the Treasurer or Chief Financial Officer has determined that sufficient funds are available in the budget, in the amount of \$2,000.00, as evidenced by the Treasurer's Certification, a copy of which is annexed hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Riverside, County of Burlington, State of New Jersey that Riverside Township participate with the League of Municipalities as *Amicus Curiae* in the appeal of the Hopewell Litigation and pay the law firm of Shain Schaffer PC, \$2,000.00

DEPARTMENT OF PUBLIC SAFETY:

Chief Eliason reported the Police Activity for January 2020: Incidents -885, Investigations -105, Adult Arrests Total -80, Motor Vehicle Summons -276, Motor Vehicle Accidents -13, Juvenile Charges -8, Curfew Violations -0, Protective Custody -0, Stationhouse Adjustments -0, Summons for False Alarms -0, False Alarm Calls -20, False Alarm Warning Letters -0. Chief Eliason reported on the various trainings that the Officers attended, the various programs in which the officers and the Chief participated in, and various awards and commendations that the police officers received. The report is on file in the Municipal Clerk's Office.

Mayor Frey reported that an EMS report was not received.

DEPARTMENT OF PUBLIC WORKS:

Mrs. Hatcher reported on following services that were provided by the Public Works Department: Two additional passes for bagged leaf pickup were done. Leaf pick-up has now ceased. Christmas Tree pickup has ceased, street patching was be performed as needed, the new tote trash cans are being delivered and they have started cleaning up all Township properties and ball fields.

DEPARTMENT OF REVENUE AND FINANCE AND ECONOMIC DEVELOPMENT:

Mr. Kirk reported on the Tax Collector's Monthly Report. The Current Collections are as of December 31, 2019 - \$18,868.35. The Collection Rate is 95.57%.

DEPARTMENT OF RECREATION:

Mr. Kimble reported that the race is live as of today and all the proceeds will be donated to Lt. Fisher with NJ TIP. Mr. Kimble is finishing up procuring food trucks, a band and a disc jockey.

DEPARTMENT OF PUBLIC EVENTS:

Mrs. Weaver stated that Read Across America will begin in March. The next Township event will be the Easter Egg Hunt on April 4th at Whomsley Field.

SOLICITOR'S REPORT:

Solicitor Grace had no report.

ENGINEER'S REPORT:

The Engineer's Report has been submitted and a copy of the report is on file in the Municipal Clerk's Office.

ADMINISTRATOR'S REPORT:

Administrator Jack reported that the Budget Meetings will commence in March. The Township has not received any figures from the State regarding aid. The Stormwater Catch Basin cleaning has commenced. The 2019 Annual Stormwater Report was submitted and there are no comments to date. The Township was awarded the following grants: NJ DOT Phase XIII in the amount of \$245,000.00 and the NJ DCA Small Cities Grant for ADA curb cuts was awarded in the amount of \$400,000.00. The TCDI Grant Application was submitted February 21, 2020.

Motion made by Mr. Kirk and Mr. Kimble to approve all the reports that were given and submitted, carried.

BILLS AND EXPENDITURES:

Motion made by Mr. Kimble and Mr. Kirk to approve the bills and expenditures for payment carried.

PUBLIC PORTION:

Mayor Frey opened the Public Portion.

- 1) Ann Law 6 Grant Street questioned when the residents will be able to get smaller totes? Administrator Jack stated the smaller totes should be ready in 5 weeks and stated that Ms. Law is on the list for a smaller tote.
- 2) Herm Maurer Trustee with the Riverside Historical Society The Township is celebrating the 125th Anniversary. The Historical Society has published a book on the 19th Century of Riverside Township.
- 3) Anthony Marzulli 540 Bridgeboro Street Questioned if recycling carts can be used for trash? Administrator Jack answered in the negative.
- 4) Michelle Higgenbothem questioned the fees for the Legalized Games of Chance Fees.

 Municipal Clerk Dydek stated that the Committee voted to waive all fees for the school.
- 5) Richard Naylor 300 Whittaker Street Questioned where he can purchase Girl Scout Cookies. Mrs. Frey stated that she is a Girl Scout Leader and stated that she will speak to Mr. Naylor after the meeting.
- 6) Kamilla Da Silva 200 S. Fairview Street questioned the Township Website. Mayor Frey stated that the Township Website is currently being upgraded. Ms. Da Silva questioned how much the Township will pay a person to perform this. Administrator Jack answered that the IT Company is working on the upgrade.

- 7) Diane Port 221 Whittaker Street Stated her concern for people parking in her driveway. Mayor Frey stated that this must be called in to the Police. Mrs. Port stated that there is constant speeding up and down the street.
- 8) Dan Cunningham 130 Jefferson Street Questioned if there is an ordinance regarding commercial vans parking overnight. Chief Eliason stated that there is an ordinance but it doesn't apply to vans. The vehicles must be over 5000lbs.
- 9) Don Nesbitt Riverside Fire Chief The Fire Company will be hosting a Citizens Fire Academy and they have 2 positions open.
