DEPARTMENT OF PUBLIC SAFETY:

Mayor Hatcher opened the Public Portion

- 1) Tammy Foster 19 Spring Garden Street Ms. Foster stated that there is an influx of vehicles in Riverside with Pennsylvania License Plates. There is a Commercial Vehicle with Pennsylvania License Plates that always parks on her street. There are numerous vehicles with license plates from Pennsylvania, New York and Maryland in Riverside Township. Ms. Foster stated that the owners of these vehicles are committing insurance fraud.
- 2) Alice Smith 413 Arch Street Delran, NJ Ms. Smith thanked the Committee for their support with the Riverside Historical Society. Ms. Smith stated that she is highly upset that the Committee insinuated that her position with the Historical Society is a hobby.
- 3) Brittney Rae Secretary of the Riverside Historical Society Ms. Rae stated that her involvement with the Historical Society is a passion, not a hobby. Ms. Rae stated that there are 30 40 members that attend their meetings and have 300 "likes" on Facebook.
- 4) Mr. Bud Maurer 202 Lippincott Avenue Mr. Maurer invited the Committee to come to the Historical Society.
- 5) Nancy Anderson 725 Perkins Lane Edgewater Park Ms. Anderson voiced her support for the Riverside Historical Society. Ms. Anderson stated that she is a realtor and some of her clients expressed concerns over the condition of the Watchcase Building and the condition of some of the streets.
- 6) David Dunkerson Mr. Dunkerson stated that he reached out to a Dunkin Donuts that has a Baskin Robbins that may be interested in locating to Riverside. Mr. Dunkerson also stated that the Little Green Football Team is now the Riverside Junior Rams. Mr. Dunkerson would like to see if there is a location that they can put a SeaBox for storage. The Committee instructed Mr. Dunkerson to contact the Administrator regarding a location for the storage box.

WHEREAS, attached as Exhibit A is a letter which memorializes the terms of an agreement reached between the Township of Riverside (the Township or "Riverside"), the declaratory judgment plaintiff, and Fair Share Housing Center (FSHC), a Supreme Court-designated interested party in this matter in accordance with In re N.J.A.C. 5:96 and 5:97, 221 N.J. 1, 30 (2015) (Mount Laurel IV) and, through this settlement, a defendant in this proceeding; and

WHEREAS, the Township filed a declaratory judgment on July 8, 2015 seeking a declaration of its compliance with the Mount Laurel doctrine and Fair Housing Act of 1985, N.J.S.A. 52:27D-301 et seq. in accordance with In re N.J.A.C. 5:96 and 5:97, supra; and

WHEREAS, through the declaratory judgment process, the Township and FSHC have now agreed to settle the litigation and to present that settlement to the trial court with jurisdiction over this matter to review, recognizing that the settlement of Mount Laurel litigation is favored because it avoids delays and the expense of trial and results more quickly in the construction of homes for lower-income households; and

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Riverside, County of Burlington, State of New Jersey, that the Mayor, or other appropriate Township official, is hereby authorized to execute the letter agreement attached as Exhibit A.

BE IT FURHTER RESOLVED, that the Township Attorney and Township Administrator are hereby authorized to take necessary action to effectuate the terms of this letter agreement, except for items where further Committee action is required, such as future ordinances or resolutions required by this letter agreement.
