PUBLIC PRESENTATION - PROPOSED FIRE HOUSE IMPROVEMENTS

Richard Horton came forward on behalf of the Fire Commissioners, along with Fire Chief Donald Nesbitt and Deputy Fire Chief Simon Santos, to present concept renderings of the improvements that are proposed for the improvements to the Fire Building.

Mayor Hatcher asked if the building would be open to the public to utilize the meeting space. Mr. Horton indicated yes.

Richard Hörton provided an overview of the floor plan of the building, indicating that the main improvements in the building would be for storage, a decontamination room and a cascade room to fill tanks. There is a proposed addition for the ladder truck, as the safety recommendations by the Fire Service that suggest that trucks should not be stacked, as well as the boat.

Mayor Hatcher asked where they fill the tanks currently. Mr. Horton indicated out of town. Mayor Hatcher asked where they shower now. Mr. Horton indicated that there is one shower in mens' room, as the Fire House is not female accommodating at present. Mayor Hatcher asked

why they need to clean the gear. Mr. Horton indicated that certain things have to go out, as the Fire House does not have commercial washers.

Mr. Horton indicated that the roof would be replaced so that there is a pitch to it, which would require gutting the second floor. In addition, there would be bunk rooms, storage, offices, a kitchen and sitting area.

Mayor Hatcher asked what the firefighters do on overnighters. Mr. Horton indicated that they bring their own items and that there is a basement.

Mr. Horton indicated that the HVAC system will be downgraded, as to accommodate the reduction in the usage. There will be new doors and renovations to the exterior that will compliment Scott Street. There will be a flag and monument.

Mr. Higgins asked if there will be sufficient parking. Mr. Horton indicated yes

Mr. Horton indicated that they will be going out to referendum on July 13th between 2 pm and 9 pm.

Mayor Hatcher asked about the parking lot. Mr. Horton indicated that the Engineer has reviewed and used coils to hold up the corner of the structure so that it does not sink.

Walter Drisell N Fairview Street asked if Fire Fighters hang out there.

Mr. Horton indicated that they do on some occasions, but that it normally is doing storms. Chief Nesbit indicated that he would like to have overnight duties in the future.

Mr. Higgins asked the price tag. Mr. Horton indicated 3.5 million. Chief Nesbitt indicated that this would be \$75/year for the average household. Mr. Drisell indicated that he felt that was nothing. Mr. Horton indicated that it may not be nothing for some people, but it is a value added project. Chief Nesbitt indicated that the conference room would be the EOC.

Brittany Rae of Delaware Avenue came forward and asked if the room would be done. Mr. Horton indicated yes and they are hopeful that there is no hold. Ms. Rae asked if the exterior will stay mostly the same. Mr. Horton indicated yes, with the exception of the doors. Mr. Horton indicated that the scroll letters.

WHEREAS, the State must bring pension and health care costs under control in order to hold down property taxes.

WHEREAS, objectives of the COALITION will include, but not limited to, conduction meetings of member's representatives to discuss common flood, groundwater and erosion problems plaguing our communities, develop strategies to mitigate these problems, and engage any Regional, State or Federal Representatives, groups, committees or commissions, as may be appropriate, to assist in developing and executing mitigation plans.

NOW THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Riverside hereby authorizes the Township of Riverside to become a member of the BURLINGTON COUNTY COASTAL COMMUNITIES COALITION.
