- 2. The Township Clerk is hereby directed to advertise and receive Proposals in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.

Administrator Jack further explained that the landlord does not pay the utility bills until he receives a shut off notice. Also, there are problems with the units in the building; however, because of the size of the apartment building, it is inspected by the State of New Jersey.

DEPARTMENT OF REVENUE AND FINANCE:

Mr. Bienkowski reported that the collection rate as of today is 59.57%. The tax rate was received and the tax bills will be mailed out as soon as possible.

DEPARTMENT OF RECREATION:

Mr. Prisco reported that the Township is moving forward with the improvements to Whomsley Field.

Administrator Jack stated that the Permit Extension Act allows for the property owner to have until June 30, 2016 to complete the site. The Construction Code Official has inspected it and a citation was issued for high grass.
