DEPARTMENT OF PUBLIC SAFETY:

Chief Eliason reported the Police Activity for February 2018: Incidents – 520, Investigations – 90, Adult Arrests Total – 79, Motor Vehicle Summons – 157, Motor Vehicle Accidents – 9, Juvenile Charges – 3, Curfew Violations – 0, Protective Custody – 0, Stationhouse Adjustments – 0, Summons for False Alarms – 0, False Alarm Calls – 13, False Alarm Warning Letters - 0. Chief Eliason reported on the various trainings that the Officers attended, the various programs in which the officers and the Chief participated in, and various awards and commendations that the police officers received. that at a certain time of the day, addicts can go into the Police Station, turn their drugs in and the Police will call Twin Oaks Recovery to try to help them.

Mr. Frey stated that Mr. Holt will give the report. Mr. Holt reported that leaves were picked up, potholes were patched, and brush was picked up from the storm. There is a tremendous amount of branches out from the storm. The PW Yard will be open this Saturday. Mr. Frey stated that the Public Works Department has done an excellent job regarding the storm clean-up. Mr. Miller questioned if any Verizon trucks have been in the Township? Administrator Jack stated that she was told that Verizon was waiting for PSE&G to finish with repairing their wires before they started repairing the Verizon wires. Mr. Frey stated that a majority of the wires are Comcast wires. Mr. Holt reported that there are multiple wires in a downed tree on New Jersey Avenue.

DEPARTMENT OF REVENUE AND FINANCE:

Mr. Hart reported that tax collection will be given as a quarterly next month.

Mr. Frey suggested the Saturday before Easter? It was determined to see what the weather brings, and if needed to change the date to April 4th.

Mayor Hatcher stated that the State would never allow this to happen.

2) Richard Naylor - 24 E. Hancock Street - questioned if Seagull Lighting was for sale? Administrator Jack answered in the negative and stated that there are two business currently there. Mr. Naylor asked if he could get his curb painted? Administrator Jack stated that the Township doesn't paint this time of the year, so it will be painted when the warmer weather arrives.

3) Diane Chambers - 42 Webster Street - Stated that she is excited and motivated to see Riverside moving forward.
