#### **ORDINANCES:**

The following Ordinance was introduced at the Regular Meeting of March 21, 2022 and advertised in the Burlington County Times on March 25, 2022. ORDINANCE 2022 - #6 entitled, "Amending Chapter 115 of the Township Code entitled, "Alcoholic Beverages."

Mayor Kimble opened the Public Portion.

Hearing nothing from the Public, motion made by Mrs. Weaver and Mr. Giovanetti that the Public Portion be closed carried.

In seeing that members of the Public did wish to speak regarding the Ordinance, motion made by Messrs. Giovanetti and Higgins to reopen the Public Portion carried.

- 1) Volkan Tamdogan 1113 N. Fairview Street Mr. Tamdogan stated that businesses have been through hard times with the Covid-19 Pandemic. Mr. Tamdogan does not understand why the hours of the liquor licenses are being closed at 1:00am.
- 2) Jose Correira Serranos Restaurant Mr. Correira stated that closing at 1:00am will really hurt the business. They will lose approximately \$2000.00 a day or \$6000.00 a week. Mr. Correira stated that the patrons will go to the bars in Philadelphia.
- 3) Caudirene Carvalho Serranos Restaurant Closing the bar at 1:00am will affect her pay.
- 4) Alfedo f. Silva Associao De Fatima Mr. Silva said that closing early will affect the club and private weddings.

Chief Jaensch addressed the public and explained the reasons that this Ordinance is being considered. Chief Jaensch said that since other liquor establishments in neighboring towns close at 1,00am, the patrons leave those premises and come to Riverside. The Riverside Police Department have responded to numerous calls, fights, disorderly customers, underage drinking and many other incidents. The Riverside Police Department had to get mutual aid from surrounding Police Departments to handle the incidents. An Officer has been injured responding to these calls. Chief Jaensch further stated that the incidents that the Police are responding to, can be reported to the Division of Alcoholic Beverage Control for enforcement.

1) Mr. Tamdogan suggested that each individual license holder be on a "watch program." Mr. Tamdogan further stated that people get injured on the job every day.

Mayor Kimble said that he as well as the Committee have to protect the residents of Riverside as well as the Police Department and it is the best interest in the Township to amend the closing hours of the licenses.

Hearing nothing additional from the public, motion made by Mr. Kirk and Mrs. Weaver that Public Portion be closed. Upon roll call, the vote was as follows: Ayes – Mrs. Weaver, Messrs. Higgins, Kirk, Giovanetti and Kimble. Nays – None. Abstain – None. Motion carried.
