Administrator Jack reported that the estimated tax bills are due on August 1, 2022 and there is a ten (10) day grace period. Friday Morning Sweeps resumed on April 1, 2022 and residential sweeps will begin on August 1, 2022. The Transit Village Grant was awarded for wayfinding signage throughout the Township. The Local Recreation Improvement Fund was awarded for improvements to the Bob Kenney Field. The NJ DOT MA grant application was submitted on July 1, 2022.

Mr. Greiner stated that the area that the test pits are being installed is not the area that has a problem. Administrator Jack stated that if the test pits are successful, they will be hard piped into the problem area. Mr. Greiner questioned if an impact study has been done with regard to the development at Riverdel? Mayor Klimble stated that a Community Impact Statement was done. Administrator Jack said that she met with the Superintendent and the Business Administrator regarding the potential impact.
