DISCUSSION:

1) Updating Fee Ordinance – The rental properties inspection fee was discussed. RESOLUTION 2023 - #122 AMENDED REDEVELOPMENT PLAN

A RESOLUTION OF THE TOWNSHIP COMMITEE OF RIVERSIDE ADOPTING THE PLANNING BOARD OF RIVERSIDE TOWNSHIP'S RECOMMENDATION THAT CERTAIN SPECIFIED PROPERTIES BE DECLARED AN AREA IN NEED OF NON-CONDEMNATION REDEVELOPMENT PUSUANT TO, N.J.S.A. 40A:12A-1, ET SEQ.

WHEREAS, pursuant to N.J.S.A. 40A:12A-6(a), the Township Committee Alberside ("Committee") directed the Township of Riverside Planning Board ("Planning Board") to conduct an investigation to determine whether Block 905, Lot 5, and Block 1401, Lot 1 of the official tax assessment maps of the municipality (hereinafter "Study Area") is an area in need of noncondemnation redevelopment pursuant to the criteria set forth in N.J.S.A. A04-12A-5; and WHEREAS, the Planning Board duly conducted after proper notice to all property owners affected by the proposed redevelopment designation and in accordance with N.J.S.A. 40A:12A-6(b), held a public hearing on _, 2023, at which time all interested individuals and property owners were provided the opportunity to address all of their questions and concerns to the Planning Board; and WHEREAS, after study and deliberation of the statements and testimony made during the public hearing and the expert testimony of Expos, AICP, PP ("Planner"), of Environmental Resolutions, Inc., the Planning Board and Township Planner and all evidence presented during the course of the public hearing, the Planning Board recommended to the Committee that the Study Area be declared an area in need of non-condemnation redevelopment as defined under N.J.S.A. 40A:12A-1, et seq.; and 023, the Planning Board adopted a resolution memorializing WHEREAS, on its recommendations to the Committee, which was subsequently transmitted to the Committee by the Township Clerk; and NOW, THEREFOERE, BE IT RESOLVED, by the Township Committee that the Township Committee accepts the findings of fact and conclusions of law made by the Planning Board as memorialized in Resolution No. as well as the comprehensive preliminary investigation report and testimony prepared by the Planner. The Township Committee makes further findings of fact and resolves that based on the recommendations of the Planning Board, the Township Committee hereby determines that the Study Area as a whole satisfies the following criteria pursuant to N.J.S.A. 40A:12A-5, and -5...: BE IT FURTHER RESOLVED, that the Township Committee hereby accepts the recommendation of the Riverside Township Planning Board and hereby designates Block 905, Lot 5, and Block 1401, Lot 1 as an area in need of non-condemnation redevelopment in accordance with *N.J.S.A.* 40A:12A-5.

BE IT FURTHER RESOLVED, that the Township Clerk, or her designee, is hereby directed to serve within ten (10) days a copy of this Resolution upon each person, if any, who filed a written objection to the Planning Board's recommendation and so shall notify the New Jersey Commissioner of the Department of Community Affairs, with service to be in a manner provided by *N.J.S.A.* 40A:12A-6b(5).
