OLD BUSINESS:

1) Laborer Positions - Superintendent Jeffrey Conard stated the Kyle starts his new job in July. Chairman Giovanetti said that the Authority is looking to fill 2 positions. Superintendent Conard said that he would like to hire for a position that would do lab work, paper work, and to do what the Assistant Superintendent is doing. This person will also have all the opportunities to go to school. Superintendent Conard stated that the paperwork is mounting. Also, one man is planning to retire. Assistant Superintendent is extremely busy with projects. Chairman Giovanetti clarified that the Authority will hire three positions. Superintendent Conard questioned if this would be a union position? Chairman Giovanetti stated that this question would need to be presented to the Labor Counsel. Treasurer Jack said that the Authority can create an administrative position however, it is not in this year's budget. This position will not be a Laborer's Position and the position will not be in the Union. Treasurer Jack reviewed the allocated budget line item. Mr. Horton recommended to hire one person now, one person when Kyle leaves and hire the Administrative employee at Budget time. Mr. Horton expressed concern over the pay increases that the Laborers received last year. Mr. George Conard said that the rates were increased because of the low pay. Superintendent Conard stated that the Union Contract needs to be amended so that the Authority can hire a person above the Laborers rate. Superintendent Conard explained that one applicant that applied has a S-2 License and C-1 License and may not accept the same salary as a laborer.

Mr. Horton made a motion to hire one person immediately, and one person in July seconded by Mr. Mingin carried.
