Mr. Smith stated that the Township should be on the offense and not the defense and do something before the problem begins. Mr. Giovanetti stated that the Township must abide by State Laws.
- 3) Michele Higginbothom 222 Rancocas Avenue Questioned the reason the Township Committee went into Closed Session during the last meeting and the public had to leave. Ms. Higginbothom said that she knows what was going in Closed Session because she was sitting behind the people that attended the Closed Session Meeting. Administrator Jack stated that it was for Contract Negotiations. Ms. Higginbothom further questioned

Contract Negotiations and stated that this is used for employee contracts. Administrator Jack explained the term "Contract Negotiations" can apply to any contract that the Township is currently or will be involved in. A Redevelopment Agreement is a contract and therefore, falls under "Contract Negotiations." Administrator Jack further stated that the Township Committee is the Redevelopment Authority and further explained the redevelopment process as it pertains to the Township Committee and the Planning Board. Ms. Higginbothom questioned if the public has any say or agrees/disagrees of what goes in that site? Administrator Jack answered in the negative and stated under Redevelopment Law, it is the purview of the Governing Body.

In hearing no additional members of the public wishing to speak, Motion wile by M. Giovanetti and Mr. Kirk that Public Portion be closed carried.

There being no further business to attend to, motion made by Mr. And Mr. Kirk that the meeting be adjourned carried.
