RESOLUTION OF THE TOWNSHIP OF RIVERSIDE, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, DECLARING AN EMERGENCY AND AUTHORIZING THE RE-ORGANIZATION MEETING TO BE HELD VIRTUALLY PURSUANT TO N.J.S.A. 10:4-9(b)

WHEREAS, the Open Public Meetings Act ("OPMA"), N.J.S.A. 10:4-6 et seq., establishes requirements for conducting meetings of public bodies to ensure transparency and public access; and

WHEREAS, N.J.S.A. 10:4-9(b) permits a public body to hold an emergency meeting without adhering to the usual notice requirements where urgent matters of public business arise that could not have been foreseen and require immediate attention to avoid substantial harm to the public interest; and

WHEREAS, on January 5, 2025, the Governor of the State of New Jersey declared a state of emergency due to a snowstorm occurring on January 6, 2025, which has rendered it unsafe to hold an in-person meeting; and

WHEREAS, the Township of Riverside is required to hold its annual re-organization meeting on or before January 7, 2025, pursuant to N.J.S.A. 40A:63-3, in order to conduct essential public business, including the swearing-in of officials and the adoption of organizational resolutions and appointments; and

WHEREAS, the governing body has determined that convening an in-person meeting under current hazardous conditions would pose a risk to public health and safety and that postponing the meeting beyond the statutory deadline is not in the public interest; and

WHEREAS, the governing body has therefore determined that the re-organization meeting must be conducted virtually using Zoom, with measures taken to ensure compliance with the public access and participation requirements of OPMA;

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Riverside, County of Burlington, State of New Jersey, as follows:

 THE TOWNSHIP SHALL ANNUALLY, AT ITS REORGANIZATION MEETING DESIGNATE THE LEGAL DEPOSITORIES FOR ALL TOWNSHIP FUNDS. THE RESOLUTION MAY BE AMENDED OR SUPPLEMENTED FROM TIME TO TIME AS THE TOWNSHIP DEEMS NECESSARY. SUCH RESOLUTION SHALL BE DEEMED AS PART OF THE CASH MANAGEMENT PLAN.

#### TD BANK

THE CHIEF FINANCIAL OFFICER SHALL DETERMINE WHICH TYPE OF LEGAL INVESTMENT WILL BEST SERVE THE NEEDS OF THE TOWNSHIP AND IS AUTHORIZED TO PLACE THE FUNDS IN ANY SUCH LEGAL INVESTMENT, UNLESS OTHERWISE RESTRICTED BY THE TOWNSHIP. INVESTMENTS MAY BE IN MONEY MARKET ACCOUNTS, SAVINGS ACCOUNTS AND CERIFICATES OF DEPOSIT. THE CHIEF FINANCIAL OFFICER SHALL ALSO REPORT MONTHLY ALL INVESTMENTS MADE OR REDEEMED OVER THE PAST MONTH.
