A RESOLUTION OF THE TOWNSHIP OF RIVERSIDE

FAIRVIEW STREET FLOOD MITIGATION/DRAINAGE IMPROVEMENT PROJECT.

WHEREAS, the Township Committee of the Township of Riverside has entered into a contract with Garrett Paul Construction LLC whose address is 915 Bennetts Mill Rd. Jackson, NJ 08527; and

WHEREAS, this Change Order (#1) is necessary to resolve a utility conflict with the proposed drainage improvements and a PSE&G gas main and a New Jersey American Water (NJAW) main; and

WHEREAS, the Township Engineer has authorized this Change Order (#1) in the amount of \$93,690.00 increasing the total contract amount to \$468,439.50 and

WHEREAS, the Riverside Township Committee does wish to approve the changes; and


