Mayor Haman opened the Public Portion.

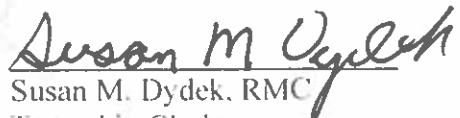
